

# Warranty

## Warranty Information - Pro Plunge

Coldture Wellness stands behind the quality and durability of its cold plunge product. Every Coldture Wellness cold plunge tub and chiller comes with a standard warranty to ensure customer satisfaction. Coldture Wellness warrants this product to be free from defects in workmanship and materials, under normal residential use and conditions. Coldture Wellness agrees, at its unfettered discretion, during the warranty period, to repair any defect in material or to workmanship. Such repair or replacement is subject to verification of the defect or malfunction and proof of purchase and Coldture Wellness retains the right to dismiss a warranty claim if foul play is suspected.

This warranty applies to commercial and residential use of the Pro Plunge and only to the original purchaser or original owner if the product was purchased as a gift. The warranty does not cover damage resulting from chemical abuse or poor water chemistry, neglected filter care and replacement, power outages, low water flow, restricted air flow, damage caused by water leaks from the unit, or any other form of neglect, misuse, or abuse. There may be other exclusions to this warranty, as described in the Limited Warranty. It is important to carefully read and understand the terms of the Limited Warranty in order to fully understand the coverage provided.

The term of warranty for components of the Pro Plunge are as follows:

**Up to 3 years warranty on the shell surface:** Coldture Wellness warrants the shell surface against blistering, cracking, and delamination. This excludes damage due to chemicals.

**Up to 2 years warranty on the chiller unit, compressor, control panel display and pump:**

Coldture Wellness warrants the chiller unit, compressor and control panel display against and pump defects in materials and workmanship. This excludes damage due to chemicals.

**Up to 2 year warranty on the ozone generator:** Coldture Wellness warrants the ozone generator against defects in materials or workmanship.

**Up to 2 year warranty on plumbing:** Coldtute Wellness warrants the plumbing against leaks from fittings, pipes, drains, joints, internal plumbing, bonded parts, jet housings. This excludes damage due to chemicals.

**1 years warranty on the thermos cover:** Coldtute Wellness warrants the thermos cover against defects in materials or workmanship.

**1 years warranty on the plastic components:** This includes jets and suction covers from cracks or material defects. This excludes damage due to chemicals.

**1 years labor on LED lights:** This includes LED lights and Logos.

Both the Coldture tub and Coldture chiller can be used outside in up to -10C/14F weather. In temperatures approaching below freezing, low heating mode is activated and keeps the water from freezing. We recommend providing shelter from direct rain to extend the chiller housing lifetime. Be cautious when operating in heavy rain as to maintain a dry plug and socket connection. The GFCI cord will protect the unit from any short circuiting but be sure that the socket is connected to ground. (Do not submerge in water - keep unit away from storm water run off)
